**WIRELESS TELECOMMUNICATIONS BUREAU SEEKS COMMENT ON REQUEST FOR
DECLARATORY RULING BY WIRELESS STRATEGIES, INC. REGARDING COORDINATION
OF MICROWAVE LINKS UNDER PART 101 OF THE COMMISSION'S RULES**

On February 23, 2007, Wireless Strategies, Inc. (WSI)¹ filed a request for a declaratory ruling that Part 101 of the Commission's rules permits a licensee to simultaneously coordinate multiple links within a single point-to-point coordination area under certain conditions.² Specifically, WSI asserts that such coordination is permitted if all transmitters within the envelope collectively comply with the Commission's Part 101 antenna standards and frequency coordination procedures.³ WSI states that this process would allow Part 101 microwave licensees to use spectrum more efficiently.⁴

On March 26, 2007, the Fixed Wireless Communications Coalition (FWCC) filed a letter (FWCC letter) expressing concern that the coordination procedures set forth in the WSI Request could result in significant interference to existing microwave stations. FWCC asks that the Commission either deny the WSI Request or open a rulemaking proceeding to fully explore the proposal. On April 6, 2007, Verizon filed a petition to deny against three pending microwave applications submitted by WSI,⁵ largely challenging the WSI Request.⁶ Verizon's Petition alleges that the process set forth in the WSI Request could cause interference to Verizon's point-to-point microwave facilities.⁷

On April 23, 2007, and April 27, 2007, WSI submitted pleadings opposing the filings of FWCC and Verizon, respectively.⁸ WSI claims that the links that are the subject of its pending applications are not encompassed under the coordination process set forth in the WSI Request, and asserts that it will use this coordination process for those sites and others only after the Commission declares that the process is consistent with the Commission's rules. On May 4, 2007, Verizon filed its Reply, reiterating its concern about possible interference caused by the process set forth in the WSI Request.⁹ On June 7, 2007 and June 15, 2007, AirTegrity Wireless, Inc. and Mt. Vernon.Net Inc. filed comments in support of the WSI Request.¹⁰

We will consider the above-mentioned pleadings and *ex parte* communications as part of the record in this Docket, WT 07-121, and will place copies of those filings in the Docket.¹¹ Parties commenting on the WSI Request **must** file their comments under the Docket number and DA number associated with this Public Notice.

Interested parties may file comments on the Request on or before **[30 days]**. Parties interested in submitting reply comments must do so on or before **[60 days]**.

All comments should reference the subject Request including the Docket number and DA number of this Public Notice. Comments may be filed using: (1) the Commission's Electronic Comment Filing System (ECFS); or (2) by filing paper copies.
